- 2 Applications for membership must be approved by our Board of Directors, which takes on average one to two months. Unless we advise you otherwise, you will receive in the meantime most membership benefits and an invoice for the membership fee. In the event that your application is rejected by the board, we will refund your fee in full.
- 3 Once your application is approved by the board, we will contact you again to confirm your organisation’s membership and provide log-in details to the members’ section of the website. At this point, we will also ask you for the names of additional colleagues who would like to receive information from us regarding your member benefits.
