
Our work will highlight the significant role the UK sustainable finance sector can play in helping to address climate concerns globally, including the SDGs, Monterrey 2 and COP21

The UKSIF submission to the FCA on the introduction of Independent Governance Committees argued that IGCs should mirror the role and duties of trustee boards in DB schemes. This includes good stewardship and individuals operating at the governance level
