UKSIF is now seeking a **Head of Public Policy & Programme Director**.

This is a permanent full-time position.

This is a great opportunity for candidates with experience of and enthusiasm for public policy work, public affairs and current affairs as well as an interest in sustainable and responsible investment, corporate responsibility and financial services generally. Excellent communication skills, sound judgement, the ability to organise yourself, a willingness to learn and a personality and style which can flourish in a small and resource-constrained team are essential. This role may be of particular interest to candidates currently working in Parliament, the public sector or for a charity or NGO.

Key Responsibilities

The Head of Public Policy will seek to influence policy-makers and regulators at the national and European level on behalf of our members and to promote sustainable and responsible investment. We are recognised leaders in the sector for our work on persuading the Government to change pensions' law on responsible investment, and we are determined to do more in that area and more widely.

You will manage our engagement with politicians, civil servants, regulators and other stakeholders as a key tool in the creation both of a supportive environment for our members' businesses and the development of a more sustainable financial system.

- Engage with a wide variety of policy stakeholders to promote the cause of responsible finance and seek to build and maintain relationships where new policy developments demand it.
- Work with UKSIF members to develop and present UKSIF’s position on key political, Governmental and regulatory issues. This will include
 - consulting members in a variety of ways (in person, by phone, webinar, convened meetings) and then drafting formal written responses to consultations
 - direct approaches to stakeholders and decision makers
 - supporting our public relations work in areas lined to policy
- In conjunction with the broader team, help to deliver our “policy programme”, a series of activities organised in conjunction with our members to spreading knowledge and capacity in chosen areas of policy such as pension and charity investment, retail finance and social investment.
- Engage with international SIFs including Eurosif, USSIF and the Global Sustainable Investment Alliance on sustainable finance policy developments
- Act as secretary to UKSIF’s Policy Committee, which provides ongoing support to our policy programme and which meets quarterly
- Advise on, and input to, UKSIF’s wider media and social media work

- A belief in a more sustainable economy combined with an understanding of members’ commercial aims
- A good understanding of Whitehall and a knowledge of Parliament and wider Government/civil service processes
- Experience in organising a response to an issue or consultation e.g. engagement to gather data and views, drafting and publicising the response, and liaising with the relevant issuing department
- A fast and accurate working style, with excellent written and verbal communication skills. The ability to manage a wide variety of tasks using good judgement and showing attention to detail
- An understanding of the activities of the various players in financial services
- Ability to relate to our varied membership and our goals
- Experience in financial services or corporate responsibility

- Experience of working in a small office.
- Understanding of responsible finance and issues in the ESG area: Environmental, Social and Governance
- A relevant degree or post-graduate qualification.
